

BUSINESS IMPACT ESTIMATE

Escambia County Boat Launch and Paddlecraft Launch Boarding Piers Ordinance

There are activities occurring at, on, and within Escambia County public boat launch sites and paddlecraft launch sites, which risk the health and safety of the public. These activities include, but are not limited to, swimming and fishing near boaters, cleaning marine animals at facilities not designed for such, discarding marine animal carcasses onto land and into waterways, and using boarding piers at boat launch sites or paddlecraft launch sites for longer than necessary to launch or retrieve vessels. Prohibiting certain activities at County facilities will protect the health and safety of the public using these facilities in Escambia County.
